I. PERFORMANCE WORK STATEMENT

The purpose of this firm fixed price purchase order is for designing, supplying and installing Poly-carbonate sheets cover to the CCAP waiting area located outside CCAP building in the eastern side of U.S. embassy Amman-Jordan in accordance with the Scope of Work.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
2. STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.
3. PROCEDURES.
 - (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
 - (b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.]

II. PRICING

A. This is a firm fixed price contract payable entirely in Jordan Dinars (JOD). Prices for all Contract Line Items (CLIN). No additional sums will be payable for any escalation in the cost of materials, equipment or labor, or because of the contractor's failure to properly estimate or accurately predict the cost or difficulty of achieving the results required. The contract price will not be adjusted due to fluctuations in currency exchange rates.

B. The rates below include all costs associated with designing, supplying and installing Poly-carbonate sheets cover services in accordance with the attached scope of work.

III. VALUE ADDED TAX

VALUE ADDED TAX. Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government.

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

A. OVERVIEW:

The United States Government (USG), Department of State (DOS) has a requirement to install Poly-carbonate sheets cover on the existing trellis located outside CCAP building in the eastern side of U.S. embassy Amman-Jordan.

The said project aims to provide a cover for the visa applicant in the CCAP waiting area and above the open area between the CCAP trellis and the CCAP building from rainwater by installing polycarbonate sheet with required supporting elements and fittings.

To this end, the USG requires quotations for a contractor to provide design, labor, and expertise to complete the proposed project.

B. GENERAL REQUIRMENET:

Requirements in this SOW serve as a guideline to the Contractor for designing, supplying and installing polycarbonate sheets materials cover to the CCAP waiting area.

The contractor must meet the work requirement, codes and standards when conducting work under this contract, these requirements do not supersede any local requirements but are intended to complement them. All materials, installation and workmanship shall comply with the applicable requirement and standards addressed herein.

The work to be completed shall include but not limited to below list of technical requirements and material specifications:

- Provide concept design for the required cover.
- Submit sufficient technical information and samples for the polycarbonate sheets and elements supporting the sheeting and for review.
- Supply and apply all required material according to specification included in this SOW, the contractor shall be responsible for providing construction services including but not limited to lifting equipment and vehicles if required, management, and professional labor.
- Provide material delivery time and work schedule.
- Follow the safety rules and regulations of the United States Embassy.

Details of all required work, material and reference drawings are provided in below scope of work.


C. SCOPE OF WORK

The work shall be performed and designed to cover the area with adequate slope towards the CCAP building roof drain.

The required polycarbonate sheets cover shall be installed at two levels 3.9m and 5m:

- Above the existing trellis beams (H:5m), Slope toward the CCAP building, Approximated area: 90 square meters*
- Open area cover between the CCAP building and the trellis beams (H:3.9m), slope toward the CCAP building roof, approximate area: 29 square meters*.

(Drawing 1 CCAP cover proposal)


*The contactor is responsible to take the exact measurements and area for the required cover.

*(For further details regarding the existing dimensions and heights elevation kindly refer to attached drawings at the end of this scope of work).

❖ **The work shall be performed to cover the following aspects:**

1. Provide concept design drawings for polycarbonate sheets. The design should include:
 - General plan with the polycarbonate sheet cover area.
 - Detailed elevations of the supporting element and fixing point locations.

- Spacing dimensions, slope direction, Elevations considering sheet and supporting element weights ...etc.
2. The contractor shall provide samples and technical sheets for the polycarbonate sheets and supporting elements to COR/Project Engineer for review and approval prior work execution.
 3. Polycarbonate sheets shall be fixed on lightweight galvanized steel structure with painted angles and adhesive material tape all around the perimeter of panels.
Color shall be approved by COR/Project Engineer.
 4. The contractor shall fix polycarbonate sheets supporting structure with matching spacing of the trellis existing structure so that the lower support elements spacing will be as per the upper trills spacing.
 5. Install horizontal beams to support the open area cover sheets, the beams shall be fixed on the existing waiting area's columns above the waiting area CCTV level, as per below proposal drawing 2.

6. Supply and apply poly-carbonate sheets as per below specifications on the supporting element structure.

❖ **Polycarbonate sheet Specs:**

- Thickness 10mm.
 - Flat.
 - Optically clear and transparent.
 - High impact resistance.
 - Temperature range of –20 to +100oC.
 - High natural light transmission.
 - Excellent fire performance.
 - Long-life UV protection.
 - Low maintenance.
 - 5 years manufacture warranty against crack, color change.
7. Install jointing material, sealant, and all required material between the sheets and around the edges to allow stretching and shrinking, prevent water infiltration or any sheet cracks, the contractor shall fix the polycarbonate sheets using proper fasteners and screws.
 8. The cover shall be installed to provide an adequate slope toward the CCAP roof building roof into the roof drain.

D. SITE VISIT

Visit the site to take all required measurement necessary for design and install the required work ,the contactor shall provide the required material according to measurement, inspect as required to field verify the condition of the various structures, validate project scope, and to provide a preliminary construction estimate for all required work herein. This means the contractor shall investigate and validate each work and area measurement also item needed as listed in this scope. Visually inspect the facilities to determine the needs and the requirements for the project and assess the situation from a professional perspective. Determine the appropriate solution or solutions to effectively and economically resolve and restore the components back to normal operating condition without additional follow-up work. Discuss with the customer to ensure no other information useful for the assessment is missing. Identify opportunities to minimize the costs of the site and visual impact on the building. Provide written recommendations to the Embassy of any required additional work, or changes to the present scope through better alternatives.

The contractor must acquaint themselves with the existing conditions and take these conditions into consideration when preparing his bid. Lack of knowledge relative to the existing site conditions will not be allowed as a basis for compensation. The contractor

shall lay out its work from base lines indicated on the scope of work and shall be responsible for all measurements. As work proceeds, check every element for space, installation, line and level. The contractor shall immediately report any problem to the Contracting Officer Representative (COR), and shall not continue the work until such problems are resolved.

Note all the material shall be high quality; the contractor shall include the material specification and brand in his offer.

E. GENERAL RESPONSIBILITIES OF THE CONTRACTOR

1. The contractor shall provide lifting equipment for installing the required material and follow safety rules and regulations as explained by U.S. Embassy POSHO or APOSHO specially for working at height all safety requirement and procedure shall have prior approval by U.S embassy PHOSHO representative.
2. Contractor's work shall comply with US building regulations and standards.
3. The contractor shall follow security directions as explained by U.S. Embassy RSO – Regional Security Officer.
4. The contractor shall have limited access into the Embassy and outside areas and contractor personnel shall always be escorted during the project.
5. All waste material to be taken from site and disposed of by the contractor.
6. All workers, vehicles and supply vendors will need an access request, which takes 48 hours to process. As such, all embassy access requests must be submitted early enough so as not to disrupt the schedule.
7. Existing systems shall not be changed or relocated without written approval from the COR.
8. All care must be taken to protect furnishings within the property and drop sheets are always to be used where necessary.
9. All documentation regarding warranties, guarantees and instructional literature are to be handed to the COR/ Project Engineer.
10. Any variations are to be priced and approved in writing by COR before proceeding with the work.
11. In case of doubt, the contractor shall always ask the COR (Contracting Officer Representative)/Project Engineer.
12. All measurements are to be confirmed by the contractor on site.

F. WORKING HOURS

Working hours will be coordinated with COR/Project Engineer. (not to interfere with consular working hours).

G. SITE PREPARATION AND CLEANING UP

The Contractor shall always keep the work area, including storage areas, free from accumulations of waste materials. Before completing the work, the Contractor shall remove the work and premises any rubbish, tools, scaffolding, equipment, and materials that are not the property of the Government. Unsightly materials and debris including excess soil, garbage, and equipment should be removed as required; while materials should be scheduled for delivery only as required for immediate use.

H. WARRANTY

The contractor shall submit a Two-year warrantee against defects, workmanship (including crack repair) and five years manufacture warranty for the polycarbonate sheets as per specification. Upon notification of such defects within the warrantee period, the contractor shall make the necessary repairs and replacements in a timely manner at their cost to the satisfaction of the COR.

I. PREFORMANCE PERIOD OF TIME

The works should be completed on site within 7 working days, and upon the COR's notification. The contractor will need to cooperate and work in accordance with the Embassy operating hours and accommodate any changes needed in timing and work days, and be willing to adjust their schedule accordingly. The contractor may submit a time extension request if needed and it will be reviewed by the COR. If approved, this time extension will be added to the original contractor duration.

Construction Safety Regulations at the U.S. Embassy, Amman

OVERVIEW:

Monitoring of Post Managed construction projects for safety, health and environmental management rests on the POSHO (Post Occupational Safety and Health Officer) and/or Assistant POSHO who will review the site for health and safety plan, coordinate with the contractor for implementing the plan, and inspect the construction site to verify the contractor's safety and health plan is being fully implemented. If the POSHO and/or APOSHO observes any violations of the contractor's safety and health plan, he/she have the authority to stop the work until appropriate control measures are in place. The contractor will be responsible to report any mishap to the POSHO and/or APOSHO. The contractor shall complete the official the Department of State mishap reporting forms provided by the POSHO and/or APOSHO.

PURPOSE:

The intent of this Scope of Work is to inform contractors of their general responsibilities for post managed construction projects. Safety regulations and standards in this SOW serve as a guideline to the Contractor for follow when working on the intended construction project. Construction activities rank high in accident rate occupations. With introduction of simple safety measures, many construction mishaps may be avoided, or the impact greatly reduced.

SCOPE OF WORK

- Per [15 FAM 935](#), contractors must provide their employees with a safe and healthful condition of employment.
- The contractor shall follow the [CONTRACTORS' GENERAL RESPONSIBILITIES](#)
- Contractor shall provide a comprehensive safety plan when bidding for construction project Scope of Work that will be reviewed by the POSHO and/or APOSHO.
- The Contractor shall attend a safety briefing with the POSHO and/or APOSHO to review the contractor's safety plan before mobilizing to execute the project.
- The contractor shall ensure proper safety; health and environmental requirements of the US Corps of Engineers- Safety and Health Requirements Manuel EM 385-1-1 applicable to their project are followed.
- The contractor shall provide all required personal protective equipment (PPE) for all the workers on site and shall enforce the use of the appropriate gear for specific hazards.

PERSONAL PROTECTIVE EQUIPMENT (PPE)


The contractors shall be briefed in the initial safety briefing on Post's PPE standards and their responsibilities while performing work at post.

- Protective equipment for eyes, face, head, and extremities, protective clothing that includes safety shoes, respiratory devices, and protective shields and barriers, shall be used wherever it is necessary by reason of hazards of processes or environment, chemical hazards, radiological hazards, or mechanical irritants encountered in a manner capable of causing injury or impairment in the function of any part of the body through absorption, inhalation or physical contact.
- Each affected employee shall use appropriate eye or face protection when exposed to eye or face hazards from flying particles, molten metal, liquid chemicals, acids or caustic liquids, chemical gases or vapors, or potentially injurious light radiation.
- Each affected employee shall use appropriate respiratory protection when potentially exposed to air contaminated with harmful dusts, fogs, fumes, mists, gases, smokes, sprays, or vapors and when such hazards cannot be reduced or eliminated by effective engineering controls.
- Each affected employee shall wear protective helmets when working in areas where there is a potential for injury to the head from falling objects. Protective helmets shall also be worn to reduce electrical shock hazards when near exposed electrical conductors which could contact the head.


- Each affected employee shall wear protective footwear (safety shoes) when working in areas where there is a danger of foot injuries due to falling and rolling objects, or objects piercing the sole, and where such employee's feet are exposed to electrical hazards.
- Each affected employee shall wear protective ear wear whenever noise exposures equal or exceed an 8-hour time-weighted average sound level (TWA) of 80 decibels and when engineering controls cannot reduce or eliminate the hazard.
- Each affected employee shall wear protective gloves when working in areas where hands are exposed to hazards such as those from skin absorption of harmful substances; severe cuts or lacerations; severe abrasions; punctures; chemical burns; thermal burns; and harmful temperature extremes.
- The Contractor shall follow the BARRICADING AND FENCING safety regulations when applicable.
- The Contractor shall follow the ELECTRICAL SAFETY and LOCKOUT / TAGOUT safety regulations when applicable.
- The Contractor shall follow the FALL PROTECTION safety regulations when applicable.
- The Contractor shall follow the HAZARD COMMUNICATIONS safety regulations when applicable.
- The Contractor shall follow the HAND AND POWER TOOL SAFETY regulations when applicable.
- The Contractor shall follow the SCAFFOLDING safety regulations when applicable.
- The Contractor shall follow the NOISE safety regulations when applicable.
- The Contractor shall follow the HOT WORK PERMIT safety regulations when applicable.
- The Contractor shall follow the TRENCHING AND EXCAVATIONS safety regulations when applicable.
- The Contractor shall follow the CONFINED SPACE ENTRY safety regulations when applicable.




(Lower Trellis Spacing CCAP trellis Columns spacing dimensions)


(CCAP trellis)



(Side view showing trellis height elevation)

(i) The Offeror (itself or through its immediate owner or highest-level owner) does, does not publicly disclose greenhouse gas emissions, i.e., makes available on a publicly accessible website the results of a greenhouse gas inventory, performed in accordance with an accounting standard with publicly available and consistently applied criteria, such as the Greenhouse Gas Protocol Corporate Standard.

(ii) The Offeror (itself or through its immediate owner or highest-level owner) does, does not publicly disclose a quantitative greenhouse gas emissions reduction goal, i.e., make available on a publicly accessible website a target to reduce absolute emissions or emissions intensity by a specific quantity or percentage.

(iii) A publicly accessible website includes the Offeror's own website or a recognized, third-party greenhouse gas emissions reporting program.

(3) If the Offeror checked “does” in paragraphs (t)(2)(i) or (t)(2)(ii) of this provision, respectively, the Offeror shall provide the publicly accessible website(s) where greenhouse gas emissions and/or reduction goals are reported:_____.

(u)

(1) In accordance with section 743 of Division E, Title VII, of the Consolidated and Further Continuing Appropriations Act, 2015 (Pub. L. 113-235) and its successor provisions in subsequent appropriations acts (and as extended in continuing resolutions), Government agencies are not permitted to use appropriated (or otherwise made available) funds for contracts with an entity that requires employees or subcontractors of such entity seeking to report waste, fraud, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(2) The prohibition in paragraph (u)(1) of this provision does not contravene requirements applicable to Standard Form 312 (Classified Information Nondisclosure Agreement), Form 4414 (Sensitive Compartmented Information Nondisclosure Agreement), or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

(3) Representation. By submission of its offer, the Offeror represents that it will not require its employees or subcontractors to sign or comply with internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting waste, fraud, or abuse related to the performance of a Government contract to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information (e.g., agency Office of the Inspector General).

(v) Covered Telecommunications Equipment or Services-Representation. Section 889(a)(1)(A) of Public Law 115-232.

(1) The Offeror shall review the list of excluded parties in the System for Award Management (SAM) (<https://www.sam.gov>) for entities excluded from receiving federal awards for “covered telecommunications equipment or services”.

- (2) The Offeror represents that—(i) It [] does, [] does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument.
- (ii) After conducting a reasonable inquiry for purposes of this representation, that it [] does, [] does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services.

Add the following provision:

52.229-11 Tax on Certain Foreign Procurements—Notice and Representation (JUN 2020)

(a) *Definitions.* As used in this provision—

Foreign person means any person other than a United States person.

Specified Federal procurement payment means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

United States person as defined in 26 U.S.C. 7701(a)(30) means—

- (1) A citizen or resident of the United States;
- (2) A domestic partnership;
- (3) A domestic corporation;
- (4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and
- (5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at www.irs.gov/w14. Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.

(d) For purposes of withholding under 26 U.S.C. 5000C, the Offeror represents that—

(1) It is is not a foreign person; and

(2) If the Offeror indicates “is” in paragraph (d)(1) of this provision, then the Offeror represents that—I am claiming on the IRS Form W-14 a full exemption, or partial or no exemption [*Offeror shall select one*] from the excise tax.

(e) If the Offeror represents it is a foreign person in paragraph (d)(1) of this provision, then—

(1) The clause at FAR 52.229-12, Tax on Certain Foreign Procurements, will be included in any resulting contract; and

(2) The Offeror shall submit with its offer the IRS Form W-14. If the IRS Form W-14 is not submitted with the offer, exemptions will not be applied to any resulting contract and the Government will withhold a full 2 percent of each payment.

(f) If the Offeror selects “is” in paragraph (d)(1) and “partial or no exemption” in paragraph (d)(2) of this provision, the Offeror will be subject to withholding in accordance with the clause at FAR 52.229-12, Tax on Certain Foreign Procurements, in any resulting contract.

(g) A taxpayer may, for a fee, seek advice from the Internal Revenue Service (IRS) as to the proper tax treatment of a transaction. This is called a private letter ruling. Also, the IRS may publish a revenue ruling, which is an official interpretation by the IRS of the Internal Revenue Code, related statutes, tax treaties, and regulations.
